

Entry Form – “Northwest Bounty” Exhibition

Celebrating the return of the Vancouver Farmers Market and the riches of the Northwest, Gallery 360 invites artists to submit entries for a three-month exhibition in the Community Room of the Slocum House. We seek artwork that depicts our region's foods, flora, wildlife, products, industries, recreation and entrepreneurs, past and present---Our “Northwest Bounty”.

Entry deadline (by email or mail): Saturday, March 4, 2017

Exhibition Dates: April 5 -- July 1, 2017

Submissions

Artists may submit up to 3 pieces for jurying. Entries may be 2D or 3D but must be able to be hung on a wall. No pedestal pieces. Maximum size: **30” x 40” including the frame.**

Only one piece per artist is eligible for acceptance to the show. **The jury fee will be paid only if one of your pieces is accepted.** If one of your entries is accepted, the fee will be \$40; Mosaic Arts Alliance members will pay a reduced fee of \$30.

All artwork must be For Sale. The gallery will retain a 40% commission for sold artwork.

Image Instructions

Artists may submit printed photos or digital images. Photos must be labeled with artist's name, title, and an arrow indicating the top. Digital files must be labeled with last name, underscore, first initial, underscore, and title (example: smith_s_untitled.jpg). Files must be jpg format and must be on a CDR or emailed, along with this form, to gallery360.vanc@gmail.com.

Please do not submit original work for jurying, or any pieces that have hung in previous shows at Gallery 360. Incomplete entries will not be considered.

Accepted Work

If your artwork is accepted, it may be delivered any time during regular gallery hours (Wednesday through Sunday, 11am to 4pm), but no later than Friday, March 31.

Any hanging wall art must be clean and have proper hanging wire on its back; no saw tooth hangers. A \$10 fee will be charged for each piece that is not properly wired for hanging. Gallery 360 reserves the right to reject any work that differs greatly from the juried sample or that is not ready for display.

All accepted pieces must remain at Gallery 360 during the Exhibition dates. Unsold artwork may be picked up beginning Sunday, July 2, 2017. Any piece not claimed by September 24, 2017 will become property of Gallery 360.

All reasonable care and precaution will be taken in the handling, storing, and installation of the artwork. Gallery 360 will not be responsible for loss or damage of any entry.
